[Akron, OH] –Summit County Public Health will offer drive thru clinic for COVID-19 vaccinations with new Moderna and Pfizer Bivalent vaccine on Tuesday, September 20, 2022 and Wednesday, September 21, 2022 at 1867 W. Market St. Akron, Ohio 43313 from 9:00 am – 3:00. We have a very limited supply of Moderna vaccine so it will be offered on a first come first served basis.

The Moderna and Pfizer vaccine will be offered, in accordance with CDC guidelines. **Appointments are required. No walk-ins will be accepted.** Masks are required at all SCPH vaccination clinics.

Based on CDC guidance SCPH will be offering Moderna & Pfizer Bivalent booster doses 2 or more months after the date of the most recent or last booster dose or the completion of your primary series for the following individuals:

## **MODERNA**

The Moderna Bivalent is authorized for use in individuals 18 years of age or older as a single booster dose administered at least 2 months after either:

- Completion of primary vaccination with any authorized or approved monovalent1 COVID-19 vaccine, or
- Receipt of the most recent booster dose with any authorized or approved monovalent COVID-19 vaccine.

# **PFIZER**

The Pfizer Bivalent is authorized for use in individuals 12 years of age or older as a single booster dose administered at least 2 months after either:

• Completion of primary vaccination with any authorized or approved monovalent COVID-19 vaccine, or



• Receipt of the most recent booster dose with any authorized or approved monovalent COVID-19 vaccine.

SCPH encourages those residents who are vaccinated and unvaccinated to continue to engage in safe and effective behaviors to reduce the spread of COVID-19:

- Stay home if you're sick, even with mild symptoms
- Be mindful in your interactions with others. Limit your chances of exposure by maintaining social distancing of at least six feet from non-household members
- Wear a mask in public
- Follow good hygiene standards:
