SAGAMORE HILLS TOWNSHIP

**A RESOLUTION EXPRESSING THE INTENT OF SAGAMORE HILLS TOWNSHIP TO SELL BY INTERNET AUCTION, PERSONAL PROPERTY, INCLUDING MOTOR VEHICLES AND OTHER PROPERTY REFERENCED IN O.R.C. SECTION 505.10 WHICH ARE NO LONGER NEEDED FOR PUBLIC USE OR ARE OBSOLETE OR UNFIT FOR THE USE FOR WHICH THEY ARE ACQUIRED.**

**RESOLUTION** introduced by David DePasquale.

**WHEREAS**, Ohio Revised Code Section 505.10 authorizes the Township to adopt a Resolution to sell by internet auction personal property owned by the Township, including motor vehicles, road machinery, equipment or tools and other personal property referenced in Ohio Revised Code Section 505.10 which are no longer needed for public use or obsolete or unfit for use for which they are acquired; and

**WHEREAS**, the Board of Trustees wishes to adopt a Resolution expressing its intent to sell this property by internet auction during the year of 2021; and

**WHEREAS**, the Board of Trustees authorizes the Chair to enter into an agreement with GovDeals.Com,Inc. to conduct such internet auctions; and

**WHEREAS**, the Board of Trustees authorizes the Fiscal Officer to advertise in a newspaper of general circulation the notice of intent to sell unneeded, obsolete or unfit municipal personal property by internet auction in 2021; and


**WHEREAS**, the Board of Trustees further wishes to authorize the Fiscal Officer to post notice of intent to sell, unneeded, obsolete or unfit personal property on the Township's website throughout the year.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Trustees of Sagamore Hills Township that it is the intent of Sagamore Hills Township to sell unneeded, obsolete or unfit personal property by internet auction. The internet auction shall be conducted by GovDeals.Com, Inc. Pursuant to Ohio Revised Code 505.10 all auctions shall be open for bidding no less than ten (10) days. The Fiscal Officer is authorized and directed to publish notice of this Resolution in a newspaper of general circulation in the Township of Sagamore Hills and posting at the Township Hall. The Fiscal Officer shall also publish notice of this Resolution on the Township's website during year of 2021. The Board of Trustees pursuant to Ohio Revised Code 505.10 further authorizes the Chair of the Board to establish the conditions of the particular sale including the requirement for pickup or delivery, method of payment, and sales tax. The information shall be provided on the internet at the time of the auction and may be provided before that time upon request for the terms and conditions have been determined.


